Hall County, Texas Regular Commissioners' Court Meeting

April 11, 2022

BE IT REMEMBERED THAT THE HALL COUNTY COMMISSIONERS MET IN A REGULAR COMMISSIONERS' COURT MEETING on April 11, 2022 with the following members present: Ray Powell, County Judge, presiding; Ronny Wilson, Commissioner Precinct #1; Terry Lindsey, Commissioner Precinct #2; Gary Proffitt, Commissioner Precinct #3; Troy Glover, Commissioner Precinct #4; Olivia M. Fisher, County Clerk; and Pauline Johnsey, Judge's Assistant. Also present were Tom Heck, County Sheriff; Kristen Dwight, County Sheriff Deputy; Sherrie Stone, County Justice of Peace, Precincts 1, 2, & 3; Janet Bridges, County Treasurer; and John Wiley.

The meeting was called to order at 10:00 A.M.

1. Opening prayer.

The opening prayer was led by Pauline Johnsey.

2. Approval of minutes of the Regular Meeting of March 14, 2022.

Motion by Commissioner Lindsey and second by Commissioner Proffitt and It is the Order of the Court to approve the minutes of the Regular Meeting of March 14, 2022. Motion passed, unanimously.

3. Reports.

Reports of Treasurer, Sheriff/EMC, Road & Bridge, Tax Assessor-Collector, County & District Clerk, Justice of the Peace 1, 2, & 3, Tax Appraisal District, and County Judge. Extension Office did not present a report.

From Justice of the Peace report:

Motion by Commissioner Glover and second by Commissioner Lindsey and It is the Order of the Court to approve a civil court fee increase of \$8.00, as mandated by the state. Motion passed, four ay to one nay.

4. Approve reports.

Motion by Commissioner Wilson and second by Commissioner Lindsey and It is the Order of the Court to approve the monthly reports as presented. Motion passed, unanimously.

5. Approve payment of bills.

Motion by Commissioner Lindsey and second by Commissioner Proffitt and It is the Order of the Court to approve the payment of the monthly bills. Motion passed, unanimously.

6. Discuss and/or action on burn ban. (Currently ON as of 11-8-21)

No action taken. Burn ban remains on.

7. Discuss and consider whether to move communication tower from courthouse property to another location, or dismantle, as part of restoration of courthouse plan.

Motion by Judge Powell and second by Commissioner Wilson and It is the Order of the Court to table the agenda item until the next Regular Commissioners' Court meeting. Motion passed, unanimously.

8. Discuss and take action on approval of enrollment of county employees for cybersecurity training.

Motion by Judge Powell and second by Commissioner Glover and It is the Order of the Court to approve enrollment for all county employees with access to a county computer and elected officials to participate in the cybersecurity training certified by the Texas Department of Information Resources. Motion passed, unanimously.

9. Discuss and take action on approval of civil filing fees and costs as budget income items for Justice of the Peace.

Motion by Commissioner Wilson and second by Commissioner Lindsey and It is the Order of the Court to approve the civil filing fees, costs, and funds, as budget income items for Justice of the Peace. Motion passed, unanimously. (Exhibit A)

 Skid Steer and attachments, to be purchased with American Rescue Plan Funding.

- Motion by Commissioner Lindsey and Second by Commissioner Proffitt and It is the Order of the Court to present Hall County Meals and Wheels with \$12,000.00 from American Rescue Plan Funding. Motion passed, unanimously.
- 4. Motion by Commissioner Lindsey and second by Commissioner Proffitt and It is the Order of the Court to approve the hiring of a fifth dispatcher/jailer to be paid with American Rescue Plan Funds for a 6-month period at \$21,000.00. Motion passed, unanimously.
- 14. Discuss, consider, and take necessary action on use of equipment, materials, purchases, county work projects, extra help or hiring of road employees on county roads and bridges by commissioners in each precinct.
