

Motion passed, unanimously. (Exhibit A)

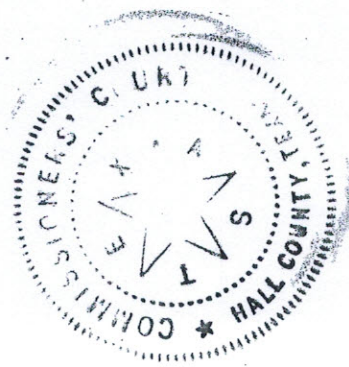
3. Adjournment

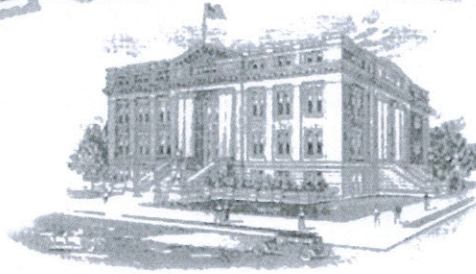




WHEREAS, the Historic Hall County Courthouse has been a County government building since 1924, and is in need of repairs, upgrades and restoration; and


