Good morning Judge Powell,

Thank you again for making time in your schedule to further discuss your upcoming courthouse restoration project with Mr. Todd Kisel and myself. I took the liberty to reach out to our Underwriting Department for their feedback regarding this matter. Based on the information discussed yesterday morning on 12/14/2023 and additional feedback from our Underwriting Department, from a Risk Management perspective, we recommend the following to mitigate potential risks with the courthouse restoration project:

- 1. Require general contractor to secure Builder's Risk coverage and add Hall County as additional insured. If the county elects not to have the general contractor purchase the Builder's Risk coverage, The Pool will need to endorse Hall County's property coverage for the \$11 million total cost of the renovation project. Our Underwriting Department will need to work with our reinsurance carrier to determine the cost for the \$11 million "property in the course of construction increased limit" Please inform the Pool if the county would like to proceed with the quote for the additional coverage.
- 2. Request contractor to obtain a performance and payment bond.
- 3. Require contractor to provide certificate of insurance to Hall County and to add Hall County as an additional insured.
 - a. General Liability -recommended limits 2 million per project with 4 million aggregate
 - b. Auto Liability
 - c. Worker's Compensation
