# Hall County, Texas Regular Commissioners' Court Meeting

JULY 10, 2023

BE IT REMEMBERED THAT THE HALL COUNTY COMMISSIONERS MET IN A REGULAR COMMISSIONERS' COURT MEETING on July 10, 2023 with the following members present: Ray Powell, County Judge, presiding; Ronny Wilson, Commissioner Precinct #1; Terry Lindsey, Commissioner Precinct #2; Gary Proffitt, Commissioner Precinct #3; Troy Glover, Commissioner Precinct #4; and Pauline Johnsey, Judge's Assistant. Also present were Tom Heck, County Sheriff; Joe and Bertha Dunn; Sean Wylie and Pat Wylie.
