A RESOLUTION BY THE COMMISSIONER'S COURT OF HALL COUNTY AUTHORIZING THE SUBMISSION OF AN FY22 GRANT APPLICATION TO THE GOVERNOR'S CRIMINAL JUSTICE DIVISION (CJD) AND DESIGNATING THE COUNTY JUDGE TO ACT AS THE COUNTY'S AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO COUNTY'S PARTICIPATION IN THE CJD GRANT PROGRAM.

WHEREAS, The Commissioner's Court finds it in the best interest of the citizens of Hall County, that the Hall County JAG program be operated for the FY 2022; and

WHEREAS, Hall County agrees to provide applicable matching funds for the said project as required by the Edward Byrne Justice Assistance Grant grant application; and

WHEREAS, Hall County agrees that in the event of loss or misuse of the Office of the Governor funds, Hall County assures that the funds will be returned to the Office of the Governor in full.

WHEREAS, Commissioner's Court designates the County Judge as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency.

BE IT REMEMBERED at a meeting of Commissioners Court of Hall County, Texas, held on the 8th day of February, 2021, on motion made by RONNY WILSON. Commissioner of Precinct No. _1, and seconded by TERRY LINDSEY, Commissioner of Precinct No. _2_, the following Resolution was adopted:

Opposition to Unfunded Mandates

WHEREAS, Texas counties are responsible for the operation and management of many and various governmental programs as required or authorized by state law; and

WHEREAS, some county government programs are fully or partially supported with funds disbursed by the State of Texas pursuant to the state appropriations process; and

WHEREAS, the State of Texas, acting through the Texas Legislature or through a state agency or executive order, may enact laws or promulgate rules that have the effect of imposing mandatory financial obligations upon Texas counties; and

WHEREAS, the State of Texas is proposing to prohibit any use of county funds for collective legislative communication, including nonprofit associations, which would require all county officials to separately analyze 7,000 bills without the benefit of assistance of outside legislative professionals and effectively silence small to medium size counties; and

WHEREAS, the State of Texas, through the Texas Legislature or through a state agency or executive order, mandates that counties implement certain governmental programs or perform certain duties and obligations including financial commitments by a county to expend county funds in connection therewith; and

WHEREAS, during each regular session of the Texas Legislature, all state funds that support county programs are reviewed through the state appropriation process and by other state budgetary review systems; and

WHEREAS, the aforementioned review process may result in a reduction, or cessation, of state financial support of county government programs causing an unforeseeable disruption and reduction of the county budget and operations; and

WHEREAS, substantial funding is mandated from county taxpayers and diverted every year from local services for the benefits for citizens of Hall County to support these mandatory financial obligations imposed by the State of Texas.

NOW, THEREFORE BE IT RESOLVED that the Commissioners of Hall County, Texas do hereby resolve that, for the foregoing reasons, it is in the best interests of Texas counties and their taxpayers to support and favor the passage of legislation in the form of an amendment to the Constitution of the State

of Texas that would expressly prohibit the imposition costs of mandatory government programs on Texas counties, whether by an act of the Texas Legislature or a state agency or by executive order, unless the State of Texas has fully funded and disbursed all necessary funds to enable Texas counties to operate said governmental program.
