INTERLOCAL AGREEMENT

This Interlocal Agreement is made by and between CHILDRESS COUNTY, TEXAS, a political subdivision of the State of Texas, and HALL COUNTY, TEXAS, a political subdivision of the state. This agreement is made pursuant to the Texas Government Code section 791, Texas Code of Criminal Procedure 2.07(b) and upon agreement of both counties (see attached minutes).

RECITALS

WHEREAS, each party finds: 1) that the subject of this Agreement is necessary for the benefit of the public; and 2) that it has the legal authority to perform and to provide the government function or service which is the subject matter of this Agreement; and,

WHEREAS, the performance of this Agreement by CHILDRESS COUNTY AND HALL COUNTY will be in the common interest of the Parties;

NOW, THEREFORE, CHILDRESS COUNTY AND HALL COUNTY agree as follows:

ARTICLE 1

TERM

The effective date of this agreement is October 1, 2020, and the same shall continue in force and effect until terminated by either party, either party may terminate the contract by giving written notice to the other party thirty (30) days prior to the date of termination.

ARTICLE 2

SERVICES PERFORMED

The Assistant District Attorney of **CHILDRESS COUNTY** shall prosecute misdemeanor cases in the County Court of **HALL COUNTY**. Said attorney shall also advise the elected county officials of **HALL COUNTY** on legal matters or any other function associated or listed in statutes concerning County Attorney duties.

ARTICLE 3

REIMBURSEMENT OF SERVICES

During the term of this contract, beginning October1, 2020, and on the last day of each succeeding month thereafter, the County Treasurer of HALL COUNTY shall pay unto the County Treasurer of CHILDRESS COUNTY the sum of \$2828.75 per month (This amount may be changed upon agreement of both, CHILDRESS COUNTY AND HALL COUNTY). Upon receipt of such amount the County Treasurer of CHILDRESS COUNTY shall deposit said funds in the county depository bank of CHILDRESS COUNTY in a designated account set up by CHILDRESS COUNTY Treasurer and CHILDRESS COUNTY Attorney. Said funds may be expended by the Assistant District Attorney of Childress County for the reasonable and necessary expenses of performing the duties of the office of HALL COUNTY ATTORNEY PRO TEM. Said bank account shall be subject to audit by either CHILDRESS COUNTY OR HALL COUNTY.

ARTICLE 4

INDEMNIFICATION

Neither party to this agreement shall be responsible to the other for liability arising from official acts or omissions by such attorney. Each party shall indemnify and hold harmless the other party from any such liability.
